I understand the inherent risks associated with participation in this Market and the possible injuries that can be sustained by participants and take full responsibility for any personal injury or illness, including death, that be sustained by me, or any loss or damage to property owned by me, as a result of or in any way arising out of, my participation in this Market, or in travel to and from this Market. I acknowledge that I am solely responsible for medical or other costs arising out of any bodily injury, illness, or property damage or loss sustained by me through my voluntary participation in this Market.

I hereby agree that in consideration of the City of Nowthen allowing me to participate in the Market, I do for myself and my heirs, executors, administrators, and assigns hereby release, waive, and forever discharge the City of Nowthen, their representatives, successors, officers, agents, elected officials and employees (hereinafter referred to as Releases) from any and all liability, claims, demands, actions, or causes of actions arising out of or related to (i) any injury or illness, including death that may be sustained by me or which I may cause during the course of my participation in the Market (ii) and loss or damage to my property, while participating in the Market and any activities incidental to participation in the Market.
