



## CHAIR RENTAL AGREEMENT

**WHEREAS**, the City desires to accommodate the needs of the Renter and allow the temporary use of the chairs pursuant to the terms of this Agreement.

**WHEREAS**, the Renter has agreed to assume full responsibility for any damage caused in connection with the use of the chairs and for the actions of those who use the chairs.

**NOW THEREFORE**, in consideration of the mutual undertakings and agreement hereinafter set forth, the City and the Renter agree as follows:

1. The renter shall have use of \_\_\_\_\_ (quantity) of the City's folding chairs from the dates of \_\_\_\_\_ to \_\_\_\_\_. The renter shall be responsible for making the arrangement for picking up and returning all rented chairs from the City Clerk.
2. Renter agrees to pay to the City \$ \_\_\_\_\_ ( \_\_\_\_\_ chairs X .50 per chair) for the use of the folding chairs.
3. Renter agrees that they have inspected each of the folding chairs being rented and find that they are in good working order.
4. In the event any of the chairs shall become lost, stolen, destroyed, or damaged, for any reason, the Renter shall, assume full responsibility for any loss, breakage, or damage caused to the chairs.
5. The renter agrees to post a damage deposit of \$25 with the City Clerk on or before the date of the rental of the folding chairs.
6. The City may deduct from the damage deposit any repair and clean-up costs it incurs to return the chairs to the same condition it was prior to the rental. Any unused portion of a damage deposit will be returned to the Renter within 30 days of the day of the rental. If the costs to clean and

repair the chairs exceed the amount of the damage deposit posted, the Renter shall be responsible for reimbursing the City for all costs the City incurs to clean and repair the chairs, including all collection costs. Renter agrees to pay all such costs within 30 days of the date of billing by the City. Bills not paid within the 30 days of the date of billing by the City shall accrue interest at the rate of 6% per year.

7. Renter hereby indemnifies and agrees to save City harmless from any and all liability and expense, including attorney's fees, arising out of the ordering, operation, use, condition, possession, storage or return of any item of the folding chairs including liability for death or injury to persons, damage to property, strict liability under the laws or judicial decisions of any state or the United States, and legal expenses in defending any claim brought to enforce any such liability or expense.
